### General vs. Special Damages in a Personal Injury ...

In general, California places no cap on compensatory damages in a personal injury case. The jury (or, in a bench trial, the judge) can award any fair and reasonable sum. Medical malpractice cases are an exception, however. In a California medical malpractice case, there is a cap of \$250,000 on pain and suffering and other non-economic damages. 1

For example, if the injuries caused a person to miss work, damages can include medical bills and lost wages.

Punitive Damages Punitive damages are awarded in personal injury cases for instances of extreme negligence, maliciousness or reckless disregard for human life. These are not meant as a form of compensation for the victim, but are rather intended as a form of monetary punishment to deter the defendant and others from engaging in similar behavior.
